Section 4: First aid measures

4.1 Description of first aid measures

The substance is a food product, therefore usually after exposure there are no adverse health effects. If symptoms occur, consult a physician, show the container or label.

<u>Skin contact:</u> take off contaminated clothing. Wash out contaminated skin thoroughly with water and soap. Consult a doctor if disturbing symptoms appear.

<u>Eye contact</u>: consult an ophthalmologist if disturbing symptoms appear. Remove any contact lenses. Wash out with plenty of water for 10-15 min. Avoid powerful water stream – risk of cornea damage.

<u>Ingestion:</u> exposure by this route does not usually occur. However, do not induce vomiting if the product is ingested. Rinse mouth with water. Never give anything by mouth to an unconscious person. Consult a doctor if needed – show the container or label.

<u>Inhalation:</u> consult a doctor if disturbing symptoms appear. Remove the victims to fresh air, keep them warm and calm.

4.2 Most import ant symptoms and effects, both acute and delayed

Eye contact: redness, tearing, temporary irritation.

4.3 Indication of any immediate medical attention and special treatment needed

Physician makes a decision regarding further medical treatment after thoroughly examination of the injured.

Section 5: Firefighting measures

5.1 Extinguishing media

Suitable extinguishing media: water mist, extinguishing foam, extinguishing powder or CO2.

<u>Unsuitable extinguishing media:</u> water jet – risk of the propagation of the flame.

5.2 Special hazards arising from the substance or mixture

May produce harmful gas containing carbon oxides if burning. Do not inhale combustion products, they can be dangerous for human health.

5.3 Advice for firefighters

Personal protection typical in case of fire. Do not stay in the fire zone without self-contained breathing apparatus and protective clothing resistant to chemicals. Extremely flammable aerosol. In case of fire, cool endangered containers with water spray. Collect extinguishing water – do not allow it to contaminate surface and ground waters.



Section 6: Accidental release measures

6.1 Personal precautions, protective equipment and emergency procedures

Limit the access for the outsiders into the breakdown area, until the suitable cleaning operations are completed. Use personal protective equipment. Avoid eyes contamination. Ensure adequate ventilation. Prohibit smoking, using open fire and sparking tools. Do not breathe aerosol.

6.2 Environmental precautions

In case of release of large amounts of the product, it is necessary to take appropriate steps to prevent it from spreading into the environment. Notify relevant emergency services.

6.3 Methods and material for containment and cleaning up

Collect the unsealed containers mechanically. Collect the leaks with incombustible liquid-absorbing materials (eg. sand, earth, universal binding agents, silica, vermiculite etc.) and place it in labeled containers. Treat the collected material as waste. Clean and ventilate the contaminated area. Use only non-sparking tools and explosion-proof equipment.

Section 7: Handling and storage

7.1 Precautions for safe handling

Handle in accordance with good occupational hygiene and safety practices. Avoid skin and eyes contamination. Do not breathe vapours and aerosols. Use only if the ventilation is adequate. Before break and after work wash hands carefully. Do not spray on hot and incandescent materials.

7.2 Conditions for safe storage, including any incompatibilities
